We provide intensive residential treatment programs and community-based counseling services that

4a (Code: ) (Expenses \$ 4,192,312. including grants of \$ 335,255. ) (Revenue \$ ) Homes for Youth (Intensive Residential Treatment): Youth Homes operates four State-licensed, six-bed homes in several cities in central Contra Costa County for abused, neglected, abandoned and traumatized foster children aged 7-17. Two of the homes are emergency assessment shelters and two provide short-term treatment programs. Youth Homes provides these youth with a wide variety of mental health support services including psychological assessment, individual and group therapy. During the year, 8,030 days of care were provided to 50 foster children.

4b (Code: ) (Expenses \$ 636,828. including grants of \$ ) (Revenue \$ ) Therapeutic Behavioral Services: Youth Homes has established a very sophisticated, preventative program with a highly specialized team of behavioral coaches. The fan out across the county each day to provide needed services and support to children, teens, young adults and families. These include intensive care coordination home-based services, individual therapy, case management, skill building and other community mental health services which were provided to almost 250 youth.

4c (Code: ) (Expenses \$ 633,040. including grants of \$ ) (Revenue \$ ) Foster Family Services and Family Pathways: Youth Homes certifies family homes in the community with placements as part of its comprehensive system of care for foster children. This is a step-down option from its residential programs and provides for a family setting option for youth who would benefit from longer-term treatment in a family environment. The Family Pathways program offers intensive care coordination and intensive home-based services to children and youth ages 5-21, primarily with open child welfare cases. By implementing these services in conjunction with a team-based planning approach (called the Child and Family Team), this program seeks to enable children and youth to live in permanent family setting in the community rather than in institutions or congregate care.
