We provide intensive residential treatment programs and community-based counseling services that

4a (Code:) (Expenses \$ 4,334,732. including grants of \$ 243,294.) (Revenue \$) Youth Homes operates four, 6-bed, state-licensed Short Term Residential Therapeutic Programs for youth, ages 7-18, in various cities in Central Contra Costa County. All four of these programs provide intensive 24/7 care, enrichment activities such as garden program, or photography class and including a wide variety of mental health services including psychiatric assessment, individual and group therapy. The youth served in these programs have experienced significant trauma and are working on significant behavioral challenges which are barriers to them living in a family environment. Over 8000 days of care were provided to 50 youth last year.

4b (Code:) (Expenses \$ 522,244. including grants of \$) (Revenue \$) Therapeutic Behavioral Services: Youth Homes provides very intensive individual, family based skill coaching, to alleviate severe behavioral challenges that would otherwise lead to children, and youth, being hospitalized or placed in residential treatment facilities. A highly trained specialized team of behavioral coaches work with children, and youth ages 3-21 years old, in their natural environments, home, school and community settings, to reduce debilitating behaviors. Approximately 250 youth are served annually in this program.

4c (Code:) (Expenses \$ 626,283. including grants of \$) (Revenue \$) Family Pathways: This Youth Homes program provides intensive care coordination, therapy, and home based mental health services for foster youth with mental health challenges. This program works intensively with the child, or youth and their family, in a team-based approach with a focus on assuring adequate services and supports are available and provided in a coordinated basis, to allow foster youth to live return to their family or live in a family setting.
